#### UNBELIEVABLE •

Last week, the Mexican train operator Ferromex suspended a dozen" injuries and deaths which occurred when illegal migrants began climbing on the trains to reach the U.S. border. Migrants have been widely seen clinging to railroad car roofs or sides, or even sneaking into containers. All of this exposes them to danger. Ferromex, which operates multiple routes through Mexico to the U.S. border area, said that the suspension would apply to 60 routes.

The decision to suspend routes cannot have been taken lightly. The financial hit to both the company and the wider Mexican economy will be real given Mexico's dependence on trade links with the U.S. Ferromex owns 6,200 miles of track in Mexico and 26 percent of Mexico's freight traffic is moved by Ferromex operated trains. Much of this train traffic ends at the U.S. border, where it normally continues into the U.S. By cutting routes to the U.S., Mexico's main market, both the company and the country are almost certainly guaranteed that migrants will once more try and taking a hit. It was no doubt for this reason that just two days later, use these trains to hitch a ride into the U.S. The Biden on September 21, Ferromex suddenly changed its position and said that certain routes would now be resumed if there was no "heightened risk" in terms of migrants. They did not define what heightened risk means, leading one to wonder if the suspension was a short-term public relations campaign. Given the widely available video of migrants riding the trains towards the U.S., company owners are no doubt aware of the problem.

Over the past few years, migrants have increasingly used trains to number of freight routes bringing cargo into the U.S. due to "half a reach the U.S. border. It is a dangerous choice for the migrants. In March 2023, police in Knippa, Texas, found a railway car filled with 17 migrants; two had already died, and five were flown to local hospitals to be treated for heat stroke and dehydration. Just two months later in May 2023, over 200 migrants were rescued from an overheating railway car in Kinney County, Texas. Fortunately, there were no fatalities, but several migrants fled and were not accounted for. Some in the open borders lobby use the tragic deaths of migrants to push for even easier entry rules into the U.S. This course of action would only lead to more tragedy and suffering. A compassionate immigration policy requires that illegal attempts to cross the border are stopped before they end in tragedy. Strong border security and the political will to enforce our immigration laws are the only realistic long-term solutions. When all the train routes resume (as some already have), it is administration must pressure Mexico to do more – on a consistent basis – to stop illegal traffic into Mexico so that the inundation at the U.S. border slows. Temporary measures like these are nothing more than a band-aid.

The following statement was issued by Dan Stein, president of the Federation for American Immigration Reform **(FAIR)**, in response to the release of DHS data indicating that August border encounters reached an all-time high: (September 22, 2023, Washington D.C.)

"More than three weeks into September, the Department of Homeland Security finally released its border encounter data for August. All it takes is a quick glance at the numbers to understand why they were trying so hard to hide the harsh reality from the American public.

"In total, there were 304,162 border encounters during August in spite of brutally hot temperatures, the highest monthly number on record. Breaking down the numbers further, southwest border encounters numbered 232,972 – an increase of 50,000 over July. Encounters of family unit jumped to 116,721, the highest in four years, while the number of unaccompanied children increased to 14,259. With still another month of data to be recorded for the fiscal year, total encounters, 2,860,127, have already eclipsed last year's totals and are on pace to exceed 3 million encounters, not including hundreds of thousands of 'gotaways'.

"While the administration has refused to even admit there is a

crisis at the border, the growing numbers of migrants entering illegally and the impact that they are having on communities all across the country can now be categorized as a disaster. It is a disaster created and perpetuated by the policies of the Biden administration. President Biden has not taken historic action to secure the border. He has taken illegal actions of historic proportions to throw open the borders.

"With onset of fall, and a push by the administration and its openborders allies to ignore federal statutes and grant work authorization to migrants more quickly, the dubious record set in August will be short-lived. Preliminary data indicate that the numbers in September will be even higher and will continue to grow until the administration decides to stop incentivizing mass illegal immigration and begins honoring its constitutional responsibility to enforce the border and our immigration laws."

We have a new selection for whom we want to donate in kind and/or money to for Troop support. The RBRW Board members recently elected to give their support to <u>Foundation for Women Warriors</u>.

The current charity began in 2005, as Military Women in Need and the name changed in 2016 to *Foundation for Women Warriors*, which is a 501 (c)(3) charity. Their headquarters are in Vista, CA. They serve Women Veterans and their children. They seek to enhance the personal economic wellbeing of women veterans and address the growing needs of the increasing population of military women transitioning to civilian life. You will be introduced to a representative at our October meeting and the foundation will give a full presentation in 2024.

They trace the roots of their organization back to 1920, when it began as a soldiers' widows' home. Their focus has evolved over the years as the needs of women veterans have changed. They currently have programs to prevent homelessness, provide financial assistance for women facing financial hardship, provide childcare assistance and have a warehouse stocked with supplies women and their children need such as: hygiene supplies, household cleaning supplies, diapers, children's clothing and toys for Christmas.

They reported that women veterans are the fastest growing population of homeless veterans, are more likely to be single parents and are often overshadowed by their male counterparts in receiving program benefits. In 2021, they served 1,016 women and children. They have 11 board members of which only the CEO receives compensation, and 175 volunteers.

#### The Document That Inspired the Declaration of Independence

It's common for Americans on July 4<sup>th</sup> to read and discuss the Declaration of Independence, and to reflect on its principles and ideas. Those principles and ideas are often attributed solely—though wrongly—to <u>Thomas Jefferson</u>, the primary author of the draft of the Declaration.

Jefferson's draft was modified in two stages: First, by a "Committee of Five" composed of Jefferson, John Adams, Benjamin Franklin, Roger Sherman, and Robert Livingston, and second by the entire Continental Congress.

The Congress discussed Jefferson's draft for three days, and made significant changes (according to Jefferson, "depredations") to his work.

In short, the Declaration was the work not of a single person, but of the representatives of the Americanpeople. <u>Jefferson</u> was the author of the draft, but it was an American Declaration.

It was, as Jefferson would later explain, "an expression of the American mind." As Jefferson implied, the Declaration of Independence merely declared, in condensed form, the political

ideas that had become consensus among the Colonists over the course of many years.

Consider the document that inspired the Declaration of Independence: the Virginia Declaration of Rights, penned primarily by George Mason and adopted by Virginia's Constitutional Convention in June of 1776, a few weeks before the Declaration of Independence was written.

Though it's largely overlooked today, much of the Declaration was drawn from Mason's Virginia Declaration of Rights. When Jefferson wrote the draft of the Declaration of Independence, he had two documents next to him: a draft constitution of Virginia and the Virginia Declaration of Rights.

The Virginia Declaration of Rights' most obvious influence on the Declaration of Independence is found in the beginnings of each document. The first section of the Virginia Declaration of Rights asserts the principle of natural rights using language similar to the Declaration of Independence:

That all men are by nature equally free and independent and have certain inherent rights, of which, when they enter into a state of society, they cannot, by any compact, deprive or divest their posterity; namely, the enjoyment of life and liberty, with the means of acquiring and possessing property, and pursuing and obtaining happiness and safety.

When celebrating the Declaration of Independence every July 4<sup>th</sup>, we should also celebrate the document that inspired the Declaration

The Virginia Declaration of Rights helps us to understand the principles of the Declaration more clearly. For instance, Jefferson did not mention the right to "property" in the Declaration, but that doesn't mean the Founders rejected a natural right to property

The Virginia Declaration specified that, in addition to the rights to life and liberty, human beings have an inherent right to "the means of acquiring and possessing property," as well as "pursuing and obtaining happiness and safety."

Mason included the right to the pursuit of happiness, but he also emphasized the right to acquire and possess property.

People often focus on the right to "possess" property, but overlook the right to "acquire" property. As author and Hillsdale College politics professor Thomas West <a href="https://has.recently.argued">has.recently.argued</a>, it's not enough for government to protect the property that people already own. There must also be an opportunity to acquire property, so that the poor as well as the rich benefit from the fruits of their labor.

Though the Virginia Declaration of Rights emphasizes the right to property, it emphasizes the right to acquire property, thus

ensuring that property rights allow all to pursue happiness.

In short, the Declaration of Independence is heavily indebted to the Virginia Declaration of Rights, which preceded it by less than a month. We deepen our understanding of the principles of the Declaration by reading it alongside the Virginia Declaration of Rights.

The Continental Congress's debt to the Virginia Declaration of Rights was so significant that, as he neared the end of his life, Jefferson had to address claims that the Declaration of Independence was unoriginal.

Jefferson admitted that the <u>Declaration of Independence</u> was not original. He wrote to James Madison that, when writing the draft, "I did not consider it as any part of my charge to invent new ideas altogether and to offer no sentiment which had ever been expressed before."

His partner on the "Committee of Five," John Adams, agreed. He wrote that "<u>there is not an idea in [the [Declaration]</u>, but what had been hackney'd in Congress for two years before."

When we celebrate Independence Day on July 4<sup>th</sup>, we celebrate the Founders' expression of the American mind. The American mind is not found in the thoughts of a single individual, such as Jefferson, but in the public philosophy contained in the documents that set forth their first principles.

Those <u>first principles</u> are found not only in the Declaration of Independence, but in important documents that inspired it, such as Mason's Virginia Declaration of Rights.






